The reporting person received the restricted stock unit award under the Clear Channel Outdoor Holdings, Inc. 2012 Stock Incentive Plan. On February 4, 2016, Clear Channel Outdoor Holdings, Inc. paid a special cash dividend of \$1.4937 per share to its stockholders. In connection with the dividend, Clear Channel Outdoor Holdings, Inc. issued restricted stock units to persons, including the reporting person, who previously had been granted restricted stock units under the Clear Channel Outdoor Holdings, Inc. 2005 Stock Incentive Plan and 2012 Stock Incentive Plan, as an anti-dilution adjustment. The award to the reporting person is reported herein.
