On October 11, 2017, (i) Clear Channel Outdoor Holdings, Inc. (the "Company") notified its parent company, iHeartCommunications, Inc. ("iHeartCommunications"), that on October 31, 2017, it intends to demand (the "Demand") repayment of \$25.0 million outstanding under the Revolving Promissory Note, dated as of November 10, 2005, between iHeartCommunications, as maker, and the Company, as payee (as amended by the first amendment dated as of December 23, 2009 and the second amendment dated as of October 23, 2013), and (ii) the Board of Directors of the Company declared a special cash dividend payable on October 31, 2017 to Class A and Class B stockholders of record at the closing of business on October 26, 2017, in an aggregate amount equal to \$25.0 million, using proceeds of the Demand. iHeartCommunications will be entitled to receive approximately \$9.5%, or approximately \$22.4 million, of the proceeds of the dividend through its wholly-owned subsidiaries. The remaining approximately \$10.5% of the proceeds of the dividend, or approximately \$2.6 million, will be paid to the public stockholders of the Company.
