Item 8.01. Other Events.

As previously announced, on January 5, 2018, (i) Clear Channel Outdoor Holdings, Inc. (the "Company") notified its parent company, iHeartCommunications, Inc. ("iHeartCommunications"), that on January 24, 2018, it intends to demand (the "Demand") repayment of \$30.0 million outstanding under the Revolving Promissory Note, dated as of November 10, 2005, between iHeartCommunications, as maker, and the Company, as payee (as amended by the first amendment dated as of December 23, 2009 and the second amendment dated as of October 23, 2013), and (ii) the Board of Directors of the Company declared a special cash dividend payable on January 24, 2018 (the "Payment Date") to Class A and B stockholders of record at the closing of business on January 19, 2018 (the "Record Date"), in an aggregate amount equal to \$30.0 million, using proceeds of the Demand.

As of the closing of business on the Record Date, there were 49,012,722 shares of Class A Common Stock and 315,000,000 shares of Class B Common Stock outstanding, resulting in a dividend of \$ 0.0824 per share. On the Payment Date, iHeartCommunications will be entitled to receive approximately \$26.8 million of the proceeds of the dividend through its wholly-owned subsidiaries, and the public stockholders of the Company will be entitled to receive approximately \$3.2 million.
